

If you made a point-of-sale purchase at a Forever 21 store using a credit, debit, or other payment card, you may be eligible for a payment from a class action settlement.

A court authorized this notice. This is not a solicitation from a lawyer.

- A Settlement has been reached with Forever 21 Retail, Inc. and Forever 21, Inc. (collectively, “Forever 21”) in a class action lawsuit about a data security incident that occurred between April 13, 2017 and October 24, 2017.
- From on or about April 13, 2017 to October 24, 2017, certain Forever 21 stores were the target of a cyber-attack in which criminals accessed Forever 21’s computer systems (the “Security Incident”). Forever 21 publicly announced the Security Incident on December 28, 2017. The Security Incident potentially resulted in unauthorized access to customer payment card data, including payment card number, expiration date, and name. Subsequently, this lawsuit was filed asserting claims against Forever 21 relating to the Security Incident. A Settlement to resolve those claims has been reached between Forever 21 and the Class Representatives on behalf of the Settlement Class defined below.
- The Settlement Class includes all persons residing in the United States who used a credit, debit, or other payment card to make a point-of-sale purchase at an affected Forever 21 store while payment card data at the store was at risk. The specific dates during which data was at risk vary on a store-by-store basis. Information regarding the specific dates for each store is included in the Appendix A attached to this notice and is also available on the settlement website at www.Forever21ClassActionSettlement.com.
- The Settlement provides payments to people who submit valid claims for time spent dealing with the Security Incident (even if only one hour was spent), for out-of-pocket expenses and charges that were incurred and plausibly arose from the Security Incident, and for other extraordinary unreimbursed monetary losses.

Your legal rights are affected even if you do nothing. Read this Notice carefully.

YOUR LEGAL RIGHTS AND OPTIONS IN THIS SETTLEMENT	
Submit a Claim	The only way to get a payment.
Ask to be Excluded	Get no payment. The only option that allows you to sue Forever 21 individually over the claims resolved by this Settlement.
Object	Write to the Court about why you do not like the Settlement.
Do Nothing	Get no payment. Give up rights to submit a claim or bring another lawsuit against Forever 21 over the Security Incident.

- These rights and options – **and the deadlines to exercise them** – are explained in this Notice.
- The Court in charge of this case still has to decide whether to grant final approval of the Settlement. Payments will only be made after the Court grants final approval of the Settlement and after any appeals are resolved.

BASIC INFORMATION

1. Why was this Notice issued?

The Court authorized this Notice because you have a right to know about the proposed Settlement in this class action lawsuit and about all of your options before the Court decides whether to give “final approval” to the Settlement. This Notice explains the legal rights and options that you may exercise before the Court decides whether to approve the Settlement.

Judge George H. Wu of the United States District Court for the Central District of California is overseeing this case. The case is known as *Hameed-Bolden, et al. v. Forever 21 Retail, Inc., et al*, Case No. 2:18-cv-03019-GW-JPR. The persons who sued are called the Plaintiffs. Forever 21 Retail, Inc. and Forever 21, Inc. are called the Defendants.

2. What is this lawsuit about?

The lawsuit claims that Forever 21 was responsible for the Security Incident that occurred and asserts claims such as: breach of implied contract and violations of California consumer protection statutes. The lawsuit seeks compensation for people who had out-of-pocket expenses, fraudulent charges, lost time spent dealing with fraudulent charges or card replacement issues, or unreimbursed extraordinary monetary losses as a result of the Security Incident.

Forever 21 denies all of the Plaintiffs’ claims and says it did not do anything wrong.

3. Why is this lawsuit a class action?

In a class action, one or more people called “Representative Plaintiffs” sue on behalf of all people who have similar claims. All of these people together are the “Class” or “Class Members.” In this case, the Representative Plaintiffs are Jowharah Hameed-Bolden and Ali Conrad O’Brien. One lawsuit resolves the issues for all Class Members, except for those who exclude themselves from the Class.

4. Why is there a Settlement?

By agreeing to settle, both sides avoid the cost and risk of a trial, and people who submit valid claims will get compensation. The Representative Plaintiffs and their attorneys believe the Settlement is fair, reasonable, and adequate and, thus, best for the Class and its members. The Settlement does not mean that Forever 21 did anything wrong.

WHO IS IN THE SETTLEMENT?

5. How do I know if I am included in the Settlement?

You are included in the Settlement Class if you reside in the United States, and used a credit, debit, or other payment card to make a point-of-sale purchase at an affected Forever 21 store while payment card data at the store was at risk. For more information on the specific stores affected visit www.Forever21ClassActionSettlement.com.

Specifically excluded from the Settlement Class are: (i) Forever 21 and its officers and directors; (ii) all Settlement Class Members who timely and validly request exclusion from the Settlement Class; (iii) the Judge assigned to evaluate the fairness of this Settlement; (iv) the attorneys representing the Parties in the Litigation; (v) banks and other entities that issued payment cards which were utilized at Forever 21 during the Security Incident; and (vi) any other Person found by a court of competent

jurisdiction to be guilty under criminal law of initiating, causing, aiding or abetting the criminal activity occurrence of the Security Incident or who pleads no contest to any such charge.

6. What if I am not sure whether I am included in the Settlement?

If you are not sure whether you are included in the Settlement, you may call 1-855-675-3135 with questions or visit www.Forever21ClassActionSettlement.com. You may also write with questions to Forever 21 Claims Administrator, PO Box 4454, Portland, OR 97208-4454. Please do not contact the Court with questions.

THE SETTLEMENT BENEFITS

7. What does the Settlement provide?

The Settlement will provide payments to people who submit valid claims.

There are two types of payments that are available: (1) Expense Reimbursement, which includes time spent (up to 4 hours @ \$25/hour), reimbursement of self-paid credit monitoring, and expense reimbursement of up to \$250 (Question 8) and (2) Extraordinary Expense Reimbursement (Question 9). You may submit a claim for either or both types of payments. You must provide proof of your class membership by submitting the number associated with the credit or debit card used at a Forever 21 store. Also, you must describe each expense and how it related to the Security Incident. You may also provide related documentation (receipts, bank statements, etc.) with your Claim Form if they are available. The Claim Form includes examples of types of expenses you may have incurred and how to document them.

8. What payments are available for Expense Reimbursement?

Class Members are eligible to receive reimbursement of up to \$250 (in total) for the following categories of out-of-pocket expenses resulting from the Security Incident:

- unreimbursed bank fees;
- unreimbursed card reissuance fees;
- unreimbursed overdraft fees;
- unreimbursed charges related to unavailability of funds;
- unreimbursed late fees;
- unreimbursed over-limit fees;
- long distance telephone charges;
- cell minutes (if charged by minute);
- Internet usage charges and text messages;
- unreimbursed charges from banks or credit card companies;
- postage;
- interest on payday loans due to card cancelation or due to over-limit situation;
- if fraudulent charges occurred on a payment card (regardless whether or not the charges were reimbursed or reversed), \$25 representing compensation for inconvenience associated with up to one hour of lost time, plus an additional \$25 per hour for up to four (4) hours of documented lost time spent dealing with the Security Incident. The claimant must provide a detailed description of the time spent or attach documentation of the time spent to the Claim Form;

- if no fraudulent charges occurred on a payment card, up to three (3) hours of lost time (calculated at the rate of \$25 per hour) spent dealing with the Security Incident, but only if at least one full hour was spent. The claimant must provide a detailed description of the time spent or attach documentation of the time spent to the Claim Form;
- costs of credit report(s) purchased by Settlement Class Members between April 13, 2017 and March 21, 2022; and
- up to \$135 in costs incurred toward credit monitoring, identity theft insurance, or similar products purchased by Settlement Class Members between April 13, 2017 and July 1, 2019.

9. What payments are available for Extraordinary Expense Reimbursement?

Class Members who had other extraordinary unreimbursed monetary losses because of information compromised as part of the Security Incident are eligible to make a claim for reimbursement of up to \$10,000. As part of the claim, the Class Member must show that: (1) it is an actual, documented, and unreimbursed monetary loss; (2) the loss was more likely than not caused by the Security Incident; (3) the loss occurred during the time period from April 13, 2017 through March 21, 2022; (4) the loss is not already covered by one or more of the categories in Question 8; and (5) a reasonable effort was made to avoid or seek reimbursement for the loss (including exhaustion of all available credit monitoring insurance and identity theft insurance).

HOW TO GET BENEFITS

10. How do I get benefits?

To ask for a payment, you must complete and submit a Claim Form. Claim Forms are available at www.Forever21ClassActionSettlement.com, or you may request one by mail by calling 1-855-675-3135. Read the instructions carefully and fill out the Claim Form. You can fill out the Claim Form online at www.Forever21ClassActionSettlement.com, or you can mail it **postmarked no later than March 21, 2022**, to:

11. How will claims be decided?

The Claims Administrator will initially decide whether the information provided on a Claim Form is complete and valid. The Claims Administrator may require additional information from any claimant. If the required information is not provided timely, the claim will be considered invalid and will not be paid.

If the claim is complete and the Claims Administrator denies the claim entirely or partially, the claimant will be provided an opportunity to have their claim reviewed by an impartial Claim Referee who has been appointed by the Court.

REMAINING IN THE SETTLEMENT

12. Do I need to do anything to remain in the Settlement?

You do not have to do anything to remain in the Settlement, but if you want a payment you must submit a Claim Form postmarked by **March 21, 2022**.

13. What am I giving up as part of the Settlement?

If the Settlement becomes final, you will give up your right to sue Forever 21 for the claims related to the Security Incident being resolved by this Settlement. The specific claims you are giving up against Forever 21 are described in Section 1.20 of the Settlement Agreement. You will be “releasing” Forever 21 and all related people or entities as described in Section 6 of the Settlement Agreement. The Settlement Agreement is available at www.Forever21ClassActionSettlement.com.

The Settlement Agreement describes the released claims with specific descriptions, so read it carefully. If you have any questions you can talk to the law firms listed in Question 17 for free or you can, of course, talk to your own lawyer at your own expense if you have questions about what the terms of the Settlement Agreement mean.

EXCLUDING YOURSELF FROM THE SETTLEMENT

If you do not want a payment from this Settlement, but you want to keep the right to sue Forever 21 about issues related to the Security Incident, then you must take steps to get out of the Settlement Class. This is called excluding yourself from – or is sometimes referred to as “opting out” of – the Settlement Class.

14. If I exclude myself, can I get a payment from this Settlement?

No. If you exclude yourself, you will not be entitled to any benefits of the Settlement, but you will not be bound by any judgment in this case or any release of claims against Forever 21 related to the Security Incident.

15. If I do not exclude myself, can I sue Forever 21 for the same thing later?

No. Unless you exclude yourself, you give up any right to sue Forever 21 for the claims that this Settlement resolves. You must exclude yourself from the Settlement Class to start your own lawsuit or to be part of any different lawsuit relating to the claims in this case. Please note, however, that the pending Forever 21 bankruptcy could also impact or eliminate your ability to sue or pursue a claim against Forever 21 if you opt out of this settlement. If you exclude yourself, do not submit a Claim Form to ask for a payment.

16. How do I exclude myself from the Settlement?

To exclude yourself, send a letter that says you want to be excluded from the Settlement in *Hameed-Bolden, et al. v. Forever 21 Retail, Inc., et al*, Case No. 2:18-cv-03019-GW-JPR. THE LAWYERS REPRESENTING YOU

17. Do I have a lawyer in this case?

Yes. The Court appointed the following lawyers as “Class Counsel”: John A. Yanchunis and Jean Sutton Martin of Morgan and Morgan Complex Litigation Group, 201 N. Franklin Street, 7th Floor, Tampa, Florida 33602; Paul C. Whalen of Law Office of Paul C. Whalen, PO Box 111, Haines Falls, NY 12436; Brian Murray of Glancy Prongay & Murray LLP, 230 Park Avenue, Suite 358, New York, NY 10169; and Jasper D. Ward IV of Jones Ward PLC, 312 S. Fourth Street, Louisville, KY 40202. You will not be charged for these lawyers. If you want to be represented by your own lawyer, you may hire one at your own expense.

18. How will the lawyers be paid?

Class Counsel will request the Court’s approval of an award for attorneys’ fees and reasonable costs and expenses of \$500,000. Class Counsel will also request approval of a Service Award of \$2,500 for each of the Representative Plaintiffs. Any amount that the Court awards for attorneys’ fees, costs, expenses, and Service Awards will be paid separately by Forever 21 and will not reduce the amount of payments to Class Members who submit valid claims.

OBJECTING TO THE SETTLEMENT

You can tell the Court that you do not agree with the Settlement or some part of it.

19. How do I tell the Court that I do not like the Settlement?

You can object to the Settlement if you do not like it or some part of it. The Court will consider your views. To do so, you must file a written objection in this case, *Hameed-Bolden, et al. v. Forever 21 Retail, Inc., et al*, Case No. 2:18-cv-03019-GW-JPR, with the Clerk of the Court at the address below.

Your objection must include all of the following: (i) your full name, address, telephone number, and e-mail address (if any); (ii) information identifying you as a Settlement Class Member, including proof that you are a member of the Settlement Class, which is described in response to question number 5; (iii) a written statement of all grounds for the objection, accompanied by any legal support for the objection that you believe is applicable; (iv) the identity of all counsel representing you, if any, in connection with your objection; (v) the identity of all counsel representing you who will appear at the Final Fairness Hearing; (vi) a list of all persons who will be called to testify at the Final Fairness Hearing in support of the objection; (vii) a statement confirming whether you intend to personally appear and/or testify at the Final Fairness Hearing; (viii) your signature and the signature of your duly authorized attorney or other duly authorized representative (along with documentation setting forth such representation); (ix) a list, by case name, court, and docket number, of all other cases in which you (directly or through counsel) have filed an objection to any proposed class action settlement within the last 3 years; and (x) a list, by case name, court, and docket number, of all other cases in which you have been a named plaintiff in any class action or served as a lead plaintiff or representative plaintiff.

To be timely, your objection must be **postmarked** to the Clerk of the Court for the United States District Court for Central District of California **no later than March 21, 2022**. In addition, you must **mail** a copy of your objection to both Class Counsel and Defense Counsel, **postmarked no later than March 21, 2022**:

20. What is the difference between objecting and asking to be excluded?

Objecting is telling the Court that you do not like the Settlement and why you do not think it should be approved. You can object only if you do not exclude yourself from the Class. Excluding yourself is telling the Court that you do not want to be part of the Class. If you exclude yourself, you have no basis to object because the case no longer affects you.

THE COURT'S FAIRNESS HEARING

The Court will hold a hearing to decide whether to grant final approval of the Settlement.

21. When and where will the Court decide whether to approve the Settlement?

The Court will hold a Fairness Hearing at 8:30 a.m. (PT) on **Thursday, April 21, 2022**, at the United States District Court for the Central District of California located at the United States Courthouse, 350 W. 1st Street, Los Angeles, CA. 90012. The hearing may be moved to a different date or time without additional notice, so it is a good idea to check www.Forever21ClassActionSettlement.com or call 1-855-675-3135. At this hearing, the Court will consider whether the Settlement is fair, reasonable, and adequate. If there are timely objections, the Court will consider them and will listen to people who have asked to speak at the hearing if such a request has been properly made. The Court will also rule on the request for an award of attorneys' fees and reasonable costs and expenses, as well as the request for a Service Award for the Representative Plaintiffs. After the hearing, the Court will decide whether to approve the Settlement. We do not know how long these decisions will take.

22. Do I have to attend the hearing?

No. Class Counsel will present the Settlement Agreement to the Court. You or your own lawyer are welcome to attend at your expense, but you are not required to do so. If you send an objection, you do not have to come to the Court to talk about it. As long as you filed your written objection on time with the Court and mailed it according to the instructions provided in Question 19, the Court will consider it.

23. May I speak at the hearing?

You may ask the Court for permission to speak at the Fairness Hearing. To do so, you must file an objection according to the instructions in Question 19, including all the information required by items (v), (vi), and (vii). Your Objection must be **filed** with the Clerk of the Court for the United States District Court for Central District of California **no later than March 21, 2022**. In addition, you must **mail** a copy of your objection to both Class Counsel and Defense Counsel listed in Question 19, **postmarked no later than March 21, 2022**.

IF YOU DO NOTHING

24. What happens if I do nothing?

If you do nothing, you will get no benefits from this Settlement. Unless you exclude yourself, after the Settlement is granted final approval and the Judgment becomes Final, you will not be able to start a lawsuit, continue with a lawsuit, or be part of any other lawsuit against Forever 21 seeking compensation relating in any way to the Forever 21 Security Incident, ever again.
